About Fairstone Bank's 2021 PublicAccountability Statement

On January 4, 2021, Duo Financial Corporation completed the acquisition of 100% of Fairstone Financial Holdings Inc. through its wholly owned subsidiary Duo Bank of Canada. Effective June 8, 2022, Duo Bank of Canada changed its name to Fairstone Bank of Canada ("Fairstone Bank").

Fairstone Bank's 2021 Public Accountability Statement details many of the Bank's and its subsidiary's activities including community engagement, philanthropic activities, charitable donations, paid taxes, number of employees, locations and more. It contains information about the 2021 fiscal year (January 1, 2021 – December 31, 2021) for Fairstone Bank and its subsidiary, Fairstone Financial Inc. ("Fairstone") (collectively referred to as "us" or "our" or "we" or "Fairstone Group"). Unless otherwise noted, all dollar amounts are expressed in Canadian currency.

Supporting our communities

Connection to the communities where we live and work has always been part of our DNA. We have proven over time that supporting our communities makes a difference. Yet, our society faces many challenges. While prosperity has increased, so has inequality. All year long, we support and create various campaigns, events and other initiatives to reinforce our CSR pillars and give back to the communities where we live and work.

Community Matters Month

Community Matters Month is a unique example of our commitment to communities. During this month, we bring together all of our employees, for an entire month of team volunteering activities and opportunities to invest in the wellbeing of our neighbourhoods. Those participating in this campaign can use their Volunteer Day, which provides eight hours of paid leave to employees who volunteer with a registered charity. In 2021, the Bank along with Fairstone and more than 120 employee volunteers used their volunteer hours to support 163 different charity events. These activities represented more than 1,200 hours of volunteer work, allowing employees to make a real difference as they support community organizations and the people they serve.

Community Sponsorship Program

We encourage our branches to connect with their local community by participating and investing in community-based initiatives that nurture the health and well-being of their neighbours. Through the Community Sponsorship program, we provide funds and volunteers for local community events. Branch employees actively participate in the events, interacting with neighbours and contributing to a positive community atmosphere. In 2021, Fairstone branches sponsored 21 organizations, with 122 employee volunteers and \$54,000 in sponsorship funds.

Leucan

In September 2021, 34 teams composed of 151 of our employees took on a series of physical and mental challenges during five weeks to raise awareness as well as funds for Leucan, an organization dedicated to helping children with cancer and their families meet the challenges they face on a daily basis. The efforts of our ambassadors and employees raised nearly \$75,000, a donation that has enabled Leucan to continue to fulfill its mission.

Annual United Way

In 2021, we participated in an annual United Way campaign to support the most underprivileged members of our communities. In total, our employees contributed \$105,000 to United Way.

Canadian Red Cross

During India's devastating COVID-19 outbreak, we responded to the international call for financial support. In solidarity with our employees, business partners, customers and their families, many of whom have ties to India, we donated \$30,000 to the Canadian Red Cross, which was working closely with the Indian Red Cross. Our contribution went directly to supporting India's healthcare system, which urgently needed oxygen concentrators and other medical supplies to help the population affected by COVID-19.







Empowering Women

Women's Committee

Our commitment to diversity, equity and inclusion sparked numerous internal initiatives including the development of a Women's Committee, a cross-functional committee of women from across the organization that will spearhead the company's effort to increase gender parity through internal education and awareness activities, as well as engage employees in supporting non-profit or charitable organizations committed to empowering women.

Parity Certification from Women in Governance

Creating an optimal and equitable working environment requires formal workplace processes to ensure everyone has access to the same opportunities. In 2021, for a second consecutive year, we received the Bronze Parity Certification from Women in Governance, a non-profit organization founded to support women in their leadership development, career advancement and access to board seats. The Parity Certification evaluates parity in decision-making bodies. It assesses each organization's commitment to policies and procedures that will enable the advancement of women at all levels of the business, thus creating a pipeline of female talent.

Canadian Women's Foundation

In 2021, we donated \$20,000 to the Canadian Women's Foundation, a national leader in the movement for gender equality in Canada. The Foundation works to achieve systemic change that includes all women through funding, research, advocacy and knowledge sharing. By supporting community programs, the Foundation empowers women and girls to move themselves out of violence and poverty and into confidence and leadership. Our donation helped ensure continuity of critical programs and services during the COVID-19 pandemic, providing vulnerable women and girls with the support they need to get through a crisis, and the resources to rebuild their lives in the months ahead.



Promoting Financial Literacy

Financial Literacy is core to our business. Our employees work year-round to help customers better understand the loan process and to ensure our audiences have access to the information they need to make informed borrowing decisions. Additionally, financial literacy is a key focus of our community engagement, corporate sponsorship and content development opportunities.

JA Canada Partnership

Fairstone Bank and Fairstone have been proud partners of JA Canada, the largest youth business education organization in Canada, since 2015. Our annual sponsorship helps enable JA Canada to provide students with the knowledge and confidence they need to succeed in school, as well as foundational financial skills to support future success in business and life. In 2021, we renewed our yearly \$50,000 agreement to support charters and programs Canada-wide. Many of our employees also volunteer to deliver JA Dollars with Sense programs in schools and virtually each year.

Financial Literacy Month

Each year in November we join many organizations in celebrating Financial Literacy Month. In November 2021, we tapped into our network and invited some partners - JA Canada, Canadian Women's Foundation, and Sun Life - to be panelists in a Financial Education webinar hosted by Fairstone. More than 120 people attended this virtual public webinar, which was the first in Fairstone's history.

Supporting customers, employees and special populations

Customers are at the heart of everything we do. We put customers first, whether the customer is a business partner or a consumer using our credit products. Products are designed with the customer in mind, leveraging research and other data to provide insights on the customer needs and wants.

Access to banking for our customers

We serve clients with diversified credit profiles, including seniors, people with disabilities and individuals with low income. By tailoring our products to the customer and offering a variety of borrowing options – from credit cards to financing options to personal loans – we enable both prime and near-prime customers to access the money they need to achieve their goals.

Credit card customers

Fairstone Bank issues credit cards that are tailored to support our partners' business while providing their customers with competitive products that support their spending needs backed by the security and convenience of Mastercard®.

Depending on the credit card product, customers are able to apply instantly in one of our partner's stores or online on their company website. Credit cards tied to the equity in their home are offered through our partner's mortgage broker network who can guide customers through the application process.

Loan customers

The customers receiving Fairstone loans and mortgages are generally in the near-prime credit space. In order to best serve Fairstone's diverse customer base, which stretches across Canada in rural, urban and metropolitan markets, we offer omnichannel customer loan application and servicing. In person, customers can apply with a lending specialist at one of 243 Fairstone branches. They can also call into one of those branches to apply by phone. For more remote customers or those inclined to apply online, customers may apply at Fairstone.ca any time and on any device.

Fairstone has designed digital servicing with the customer in mind. We offer online tools, such as loan calculators and an instant quote, that promote informed borrowing decisions. Throughout the online application experience, knowledgeable lending specialists are standing by to support the applicant with the same expert service as provided in the branch.

Our loan customers benefit from fixed interest rates and terms. These product features enable borrowers to maintain a consistent repayment schedule and and keep their budget on track. Borrowers can use a Fairstone loan to help rebuild credit, having the opportunity to make sound financial decisions related to on-time payments as well as the choice to use a loan proactively for for debt management via debt consolidation.

Fairstone lending specialists are trained to be open, honest and consistent with our terms and processes; beyond "disclosing," we work to ensure customers' understanding. Additionally, using our "Ability to Pay framework", Fairstone employees and systems ensure loans are tailored to each customers' unique needs and circumstances.

Financing customers

Fairstone provides point-of-sale financing programs across several key segments that are tailored to help Canadian businesses grow while giving their customers the convenience and flexibility they need to pay for high ticket purchases over time.

From furniture, to electronics, to service segments such as dentistry, optometry and veterinarian, Fairstone offers frictionless omni-channel financing through its online application which lets consumers apply for financing anytime, anywhere, on any device with an instant credit decision.

Supporting seniors

We recognize the importance of supporting the needs of seniors since they represent a significant portion of our clients. This is why we've made several improvements to support this.

Code of Conduct for the delivery of banking services to seniors

As a member of the Canadian Bankers Association, Fairstone Bank adopted the Code of Conduct for the Delivery of Banking Services to Seniors (the "Code") in 2019. This voluntary Code of conduct sets out principles to guide banks that deliver banking products and services to seniors in Canada.

In 2021, we designated a seniors champion to promote seniors' interests. The duties of the seniors champion include providing leadership in the implementation of the Code, promoting and raising awareness of matters affecting seniors, and engaging with seniors, subject matter experts and organizations representing seniors.

Communication with seniors

Our employees and representatives are trained to deliver highquality customer service that considers the needs of seniors. All employees undergo annual training on communicating with and providing services to seniors. Senior customers with accessibility requests may contact the Customer Care Centre to request client communication materials.

Financial abuse and fraud protection resources for seniors

Seniors are important for us, and over the past year, we have implemented several initiatives to better support this client group. For example, we created dedicated resources on our website that support seniors' ability to better manage their finances, avoid financial abuse and protect themselves from fraud, including telemarketing scams and theft and identity fraud. This information is also available physically upon request.

People with disabilities

We are committed to ensuring equitable treatment to those with disabilities. In addition to providing employee training and designing facilities that ensure people with disabilities are able to maintain their dignity and independence, we actively seek to prevent barriers and remove obstacles faced by people with disabilities, including barriers to accessibility. As part of this work, we ensure ongoing adherence to accessibility requirements under the Accessibility for Ontarians with Disabilities Act (AODA).

Information and communications

We are committed to meeting the communications needs of people with disabilities. We will consult with individuals with disabilities to determine their specific information and communication needs. Fairstone Bank's websites and website content – www.FairstoneBank.ca and www.Fairstone.ca – conform to WCAG 2.0, Level AA requirements.

We are dedicated to providing feedback processes that are accessible to people with disabilities upon request, including:

- Multiple feedback channel options such as email, telephone, or mail
- Updates to the "Accessibility" section of Fairstone's website <u>www.Fairstone.ca</u> – to include additional contacts for people with disabilities

Accessible Emergency Information

We are also committed to providing customers and clients with publicly-available emergency information in an accessible way upon request. We also provide employees with disabilities with individualized emergency response information when necessary.

Training

Fairstone Bank and Fairstone provide training to employees, volunteers and other staff members on Ontario's accessibility laws and the Human Rights Code relating to people with disabilities. Training is provided in a way that best suits the duties of employees, volunteers and other staff members.

We ensure that all employees are provided with the training needed to meet Ontario's accessibility laws. In addition to providing initial training to all new employees, Fairstone Bank provides ongoing training for employees with special attention given to any changes to the policies, practices and procedures governing the provision of goods or services to people with disabilities.

Design of public spaces

We meet the Accessibility Standards for the Design of public spaces when building or making major modifications to public spaces. We have put the following procedure in place to prevent service disruptions to the accessible parts of its public spaces:

- Fairstone Bank and Fairstone are advised by property management any time there is a disruption of services or access to the building(s) by the public.
- We provide temporary arrangements where necessary to accommodate public access to our business offices when accessibility is impacted.

In the event of a service disruption, we will notify the public of the service disruption and alternatives available.

Accessible employment

We are committed to fair and accessible employment practices and fosters an environment of respect and inclusivity. From our "Careers" website to our application forms, candidates are aware at the onset of their application that Fairstone Bank as well as Fairstone are equal opportunity employers. We accommodate people with disabilities during the recruitment and assessment processes, and when people are hired.

We also have a process for developing individual accommodation plans and return-to-work policies for employees absent due to a disability.

Listening to what our customers and the public have to say

We regularly hold customer consultations through customer experience surveys and focus groups. Additionally, we conduct consultations with the general public through an annual survey. These consultations allow us to better understand our customers' needs and realities, to better adapt our product offering.

Public consultations

It is important to us that our products meet the needs of our customers. Where there are opportunities, we conduct surveys related to products and services, and collect primary research regarding the experience of acquiring those services. Additionally, we survey members of the general public to identify trends or emerging issues that may impact our customers and Canadian consumers in general.

In 2021, our consultations centered around existing products and services, the application experience, and the impact of the COVID-19 pandemic on Fairstone Bank customers and the general public. Specifically, our research focused on the impact the COVID-19 pandemic has had on consumers' perception of their financial situation.

Moving forward, we will also look for opportunities to engage in consultations related to our complaint handling process.
